## **INTRODUCTION**

Our Club was founded in 1969 to cater for those owners of purebred dogs who were interested in training their dogs to Obedience Trial standard. The club was so successful in this regard that it was granted affiliation with KCC (Kennel Control Council). In 1979 Victorian Canine Association (now Dogs Victoria) accepted all dogs into Obedience trials and the club was then also opened to all dogs.

## **CLUB RULES**

- 1. Your dog is to be kept on leash at all times. The only exception is when given explicit instruction to work off lead in class.
- 2. Handlers wishing to leave their dogs tethered on Club grounds should only do so if their dogs are safe with people, especially around children. No dog may be tethered where it can reach another dog.
- 3. Dogs must be fully immunised before coming to classes which needs to be renewed annually.
- 4. Any sick dog, or one suffering from a communicative illness, are not to come to classes until Vet cleared.
- 5. Handlers are responsible for removal of their dog's excreta from the training area.
- 6. We teach rewards-based training. Physical and excessive verbal abuse of dogs is not allowed. Any observed behaviour of this type will lead to expulsion from the club.
- 7. Instructors have authority over their classes and may ask a member to take their dog out of class if it is overly disruptive.
- 8. While at the grounds, before and after classes, please remain in control your dogs, and respect the space of other dogs and handlers.
- 9. Dogs in season should not attend training for four weeks. However, this does not mean you should stop attending classes nor cease the training of your dog.
- 10. If an Instructor considers your dog to be aggressive, the Chief Instructor will evaluate your dog as to its suitability to be trained at ESODC. If required, the dog may be asked to wear a muzzle while at training or private professional instruction / organisations may be recommended. Remember, we are a Community Dog Club, we do not offer specialised behavioural modification training.

Feedback from participants has been very positive, with a very good turnout despite the poor weather leading up to the trial. And congratulations to all competitors from all clubs, but especially those from ESODC. I know how much effort goes into trialling at all levels, so well done all.

I would like to add my personal thanks to all those who helped out, on the day, in the preparation of the food, raffle, ground setup, competitor prizes and ribbons, and organisation of the trial itself.

Our club President, Rhonda Cheesman is also our Trial Secretary. Both roles take up an enormous amount of time and effort, so I would like to give a special word of thanks for the many hours she puts into our club, ensuring all goes well on the day, and throughout the year. So, on behalf of our club members Rhonda, thank you.

The new Instructor Training course has commenced with 5 keen participants, so thanks for their interest in helping to support their club in this manner. It is only through our volunteers that we can offer the training we do.

You may notice our Instructors with new polo shirts in our club colours. This is to enable members to easier distinguish Instructors out on the field, and to create a "team mentality" within the Instructing group.

On another note, the President, Vice-President and myself recently met to review several incident reports raised by various club members.



One of the most common occurring issues was that of loose or uncontrolled dogs on the field, either member dogs, or general public dogs using the oval during club times, when it is reserved exclusively for our members.

Our review came up with the following corrective actions which I would like to communicate to you now:

- All Instructors to be issued with and to carry a slip-lead to assist them in gaining control of loose dogs.
- All Instructors to be issued with a
   whistle to attract the attention of
   other Instructors / volunteers to warn
   them and their classes that a dog is
   loose, or assistance is needed for other
   reasons (such as a medical
   emergency).
- Members are to look after the welfare and maintain control of their own dogs whilst the Instructors manage any loose dog situation.
- Mobile signs to be positioned in prominent positions around the oval informing general public that the oval is not to be used for off-lead activity whilst club is using it.

We take all incident reports seriously, so if you have anything you may have observed reviewed, the Incident Report paperwork can be accessed in our clubroom.

That's it from me, so until next time, enjoy your training and remember, have fun with your dogs...

## What is R.A.T.G.?

RATG is the Retrieving Ability Test for Gundogs, and has been around under several different names for years. But, for the first time under the 2011 ANKC rules a dog can now gain a title;

- · NRA (Novice Retrieving Ability) and
- · ORA (Open Retrieving Ability).

The exercises are straight forward and set to allow a gundog to display, in an enthusiastic and enjoyable way, what it was bred for.

Basic heeling and recall exercises are done without lead or any type of collar on the dog, to show the judge the dog is under control before proceeding to the retrieving test.

Judging begins on all exercises as soon as the lead is removed from the dog.

For the Novice test there will be 50 metre retrieve, followed by a further 70 metre retrieve. When dog & handler eventually progress to the Open level there are a few extra retrieving tests to overcome.

All competing dogs are placed in 'the hide'. This is an out of sight area designated by the judge. Not only is it unfair for dogs running later in the day to see the dummies repeatedly land, but it is detrimental to these dogs to see the runs from an incorrect angle. The handlers may join 'the gallery' until it is time to return to the hide and prepare their dog for their run. The gallery is an observation area for all spectators.

To set up for the retrieve, the handler will have the dog beside him, between the pegs, facing the area where the dummy or bird (game) will land. When the game leaves 'the thrower' the dog is required to 'mark' where it landed. The thrower is a manned mechanism to project the game simulating flying. The dogs need to be taught to watch straight ahead and mark the spot after the game lands - like they were taking a photo.

The dog must remain beside the handler until there is a command to fetch. The judge is looking for the dog to run directly to the game, pick it up gently and return it directly to the handler. This is referred to as 'the hand over'. Walking away from the pegs after a successful run, is very satisfying for the dog and handler.

RATG trials do not require the huge paddocks necessary for Retrieving trials, it is necessary to have adequate space for two retrieves that are not over the same ground, and the grass should not be cut less than 100mm.

RATG trials have been held at KCC Park, Gippsland, Melton, Mt Duneed, Retrieving Trials, Obedience clubs & areas around the State.

All Registered Gundog breeds and Associate Registered Gundogs are eligible to enter RATG competitions.

Associate Gundogs are recognized as pure breed gundogs that are either desexed or without papers. They are required to apply to the RAFT committee for the issue of an approval certificate to compete.
